

# FAQs for Student Health Insurance Plan, 2023 - 2024

#### What do I need to know about the requirements for having health insurance?

- Students will be advised if they are required to take the student health insurance plan (mandatory) or if they are auto-enrolled (automatically enrolled in the student health plan but can waive coverage by providing proof of enrollment in a comparable plan) or if they are eligible to enroll in the student health plan if they choose, but they are not automatically enrolled (voluntary).
- School of Dentistry students are required to have active health insurance but are **not** required to
  purchase the university-sponsored student health insurance plan. All School of Dentistry students are
  able to enroll voluntarily in the student health insurance plan; the only exception is students who live on
  the McNichols Campus. Instructions on verification of health insurance coverage will come directly from
  the School of Dentistry.

### What health coverage through a parent qualifies as meeting the requirement to allow me a waiver?

• If your parent or guardian is covered under a group health plan (through an employer) AND you are listed with that employer as a dependent of your parent, you are likely eligible to waive coverage. Most group plans allow for coverage of a dependent up to age 26, although this does vary.

#### What does auto-enroll mean?

- Auto-enrolled means that you are required to carry personal health insurance and have been automatically enrolled in the student health plan. However, if you have comparable health insurance coverage already and wish to continue with that coverage, you will need to "waive" coverage of the student health plan through the link on (insert link) page.
- The approval process to waive coverage takes between 3 to 10 business days and needs to be completed no later than September 30

## I have all **ONLINE CLASSES**; do I still need to provide proof of health insurance?

• If you are online only and live off-campus, you do not need to provide proof of insurance; however, you are eligible to enroll if you choose. If you are a student living in residential housing (a dorm) and have all online classes, you will be auto-enrolled in the student health plan and can either waive coverage or continue with the student health plan.

#### What is involved in the waiver approval process?
